# Message from the Deputy Minister of Manitoba Education and Early Childhood Learning

his spring, we take a moment to remember and honour the life and work of Nello Altomare, our late Minister of Education and Early Childhood Learning. Minister Altomare was a passionate educator who cared deeply about connecting with and improving the learning experiences of all students and children. He also had a passion and commitment to growing a high-quality early learning and child care system in the province. Among his many contributions, Minister Altomare oversaw the development and implementation of Canada's first universally accessible school nutrition program, which ensures that students in publicly funded schools have access to nutritious food, so they can focus on learning and reach their full potential.

While we continue our work towards creating the conditions for every child in Manitoba to achieve success, we also take time to welcome our new Minister of Education and Early Childhood Learning, the Honourable Tracy Schmidt, Member of the Legislative Assembly for Rossmere. Minister Schmidt is familiar with the portfolio, having served in an acting capacity since last October.

I am proud to share updates on several important initiatives that are helping to shape the future of education and early childhood learning in our province. Work continues in the early learning and child care sector at the national and provincial levels to develop a workforce strategy focused on recruitment, retention, and recognition, while supporting the long-term stability of the Canada-wide system. To this end, Manitoba was recently made the provincial co-chair for the Federal, Provincial and Territorial Forum of Ministers Most Responsible for Early Learning and Child Care. The current early learning and child care Canada-Manitoba agreements have recently been extended through 2031, and added funding has also been committed to create additional child care spaces in schools, health care facilities, and post-secondary institutions.

On the Kindergarten to Grade 12 side, we have launched the Education Data Dashboard to summarize and visualize provincial student achievement data, amended The Education Administration Act to formalize changes to the process for addressing teacher and school clinician professional misconduct, and released details on schools funding for the 2025/2026 school year.

These efforts, along with many others, are a direct reflection of the ongoing dedication and commitment from everyone involved in education and early childhood learning. Let us continue to be inspired by the late Nello Altomare and carry forward the vision of providing every child with the opportunity to succeed.

# Ministers Gather to Discuss Multilateral Workforce Strategy and Strengthening the Long-Term Sustainability of the Canada-Wide System

On November 28, 2024, the Honourable Tracy Schmidt, Acting Minister of Education and Early Childhood Learning, and Sarah Whiteford, Assistant Deputy Minister of Early Learning and Child Care, visited the birthplace of Confederation—Charlottetown, Prince Edward Island—for the third meeting of the Federal, Provincial and Territorial Forum of Ministers Most Responsible for Early Learning and Child Care.

Established in 2022, the Forum serves as a table for early learning and child care ministers to share information and best practices, and to set priorities for multilateral collaboration. For the last two years, Prince Edward Island has held the role of co-chair; however, in November, upon the conclusion of this most recent meeting, this responsibility has transitioned to Manitoba, which will share this responsibility with the Honourable Steven MacKinnon, Minister of Jobs and Families.

At the meeting, ministers emphasized that a strong workforce is vital for quality early learning and child care. They reviewed a draft multilateral workforce strategy that is centred around three pillars: recruitment, retention, and recognition.

The early draft highlights efforts already underway in each province and territory to strengthen the workforce, such as by improving wages and benefits. Ministers explored opportunities to further collaborate to stabilize and support the workforce, noting that additional consultation and engagement are essential to developing a robust strategy.

During the meeting, ministers reflected on the significant work that has taken place to strengthen early learning and child care across Canada, and the critical importance of continuing to build on this important work with long-term, sustainable funding. As stated in the Canada Early Learning and Child Care Act, the Government of Canada is committed to maintaining longterm funding for early learning and child care programs and services.

The ministers also used the meeting as an opportunity to mark the collective achievements of the past year, highlighting that the families of over 750,000 children across Canada are already benefiting from affordable, high-quality child care. They also discussed the critical importance of meeting the unique needs of local communities, including Indigenous communities, in their early learning and child care systems.

## **Child Care Space Creation and Investments in Professional Training** and Curriculum

As of February 2025, Manitoba has opened nearly 8,300 spaces and committed to another 6,650 spaces, for a total of almost 15,000 new spaces since 2021 for children twelve and under throughout the province.

This includes 4,300 spaces opened and over 5,750 spaces committed for children under seven, moving Manitoba closer to the 23,000 spaces goal outlined in the Canada-Manitoba Canada-Wide Early Learning and Child Care Agreement. Additionally, through provincial

investment, nearly 4,000 school-age spaces have opened and over 900 school-age spaces have been committed for children ages seven to twelve.

To support the growth in spaces, continued investments under the Canada-Manitoba Canada-Wide Early Learning and Child Care Agreement are being made to support workforce growth, including additional programming for newcomer and Indigenous learners, grant funding to enhance outdoor early education, and tuition supports for early childhood education career seekers.

#### Where are the child care spaces being created?

In February 2025, the governments of Manitoba and Canada completed negotiations for an action plan under the infrastructure funding annex to the Canada-Wide ELCC Agreement, detailing how Manitoba will invest \$20.9 million in federal funding over three years to support the creation, through the Health and Child Care Infrastructure Project, of approximately 324 quality and flexible child care spaces in three health care facilities across the province.

Last month, Manitoba also announced the creation of an additional 256 new child care spaces in partnership with school divisions and 128 new child care spaces in post-secondary institutions for children under the age of seven.

- For school divisions, these investments will provide new infant and preschool child care spaces through six new initiatives under the School-Based Child Care Expansion Project, in addition to the 36 previously announced projects.
- For post-secondary institutions, the additional investments will create new infant and preschool spaces at Red River Polytechnic and University College of the North's Thompson campus through the Post-Secondary Child Care Expansion Project, in addition to the nine previously announced projects.

A Request for Proposals was issued in October 2024 to develop, over the next two years, 29 stand-alone child care centres to be located on school property, leveraging modular building technology. A similar development method has been used to construct 22 high-quality child care facilities across the province through the municipalities' and Indigenous governing bodies' Ready-to-Move Child Care Initiative. These Ready-to-Move child care centres have been constructed in an average of nine months, from piles being poured to occupancy. An information session with participating school divisions will be organized in spring 2025 to kick off the next phase of the School-Based Child Care Expansion Project.

# Canada Announces Additional \$36.8 Billion for Child Care and **Launches National Child Care Workforce Campaign**

Over the past two months, Manitoba has worked closely with our federal partners on a plan to extend our current early learning and child care agreements. On March 6, 2025, the Government of Canada announced it had reached agreements with 11 of the 13 provinces and territories, including Manitoba, resulting in an additional \$36.8 billion invested in child care across the country until 2031. Beginning in 2027/2028, provinces and territories will also receive a 3 per cent funding increase every four years. For Manitoba, this will mean an additional \$1.9 billion in child care funding that will continue to support important investments in increased access to affordable, quality child care and a stronger child care workforce.

To support recruitment of the future child care workforce, Economic and Social Development Canada has launched a national advertising campaign that will run most of March and again in late spring to promote the early childhood education profession as a career of choice and to support workforce recruitment into the early learning and child care sector.



# Changes to the Process for Addressing Professional Misconduct of **Teachers and School Clinicians**

On January 6, 2025, amendments to The Education Administration Act came into force to implement a new process for addressing teacher misconduct and for publicly sharing related information. The purpose of the amendments is to transition away from the process involving the Certificate Review Committee, which provides recommendations for the Minister's decision regarding a teacher's or clinician's certificate status, and to establish a more transparent and accountable process for teachers and school clinicians by allowing for citizen representation on hearing panels, public hearings of misconduct cases, and public reporting of misconduct decisions. The new process includes the appointment of an independent commissioner to receive and investigate complaints from individuals and employing authorities regarding professional misconduct of teachers and clinicians. It will also create a roster of members that will form panels to hear matters referred to them by the commissioner, and establish a public registry that contains specific information about each teacher and clinician certified in Manitoba after January 1, 1960, and any record of suspension or cancellation of a teacher's or clinician's certificate since January 1, 1990. The amendments also set out the powers and duties of the Director of Certification.

Bobbi Taillefer is Manitoba's inaugural Commissioner of Teacher Professional Conduct. She has served in the Kindergarten to Grade 12 sector in a variety of capacities, including as a teacher, a principal, and in roles with the Manitoba Teachers' Society, including general secretary. She has also served as Deputy General Secretary of the Elementary Teachers' Federation of Ontario and, more recently, as Executive Director of the Saskatchewan Teachers' Federation. We welcome Bobbi to her new role and look forward to working with her!

# Schools Funding for the 2025/2026 School Year

On February 10, 2025, the department announced an increase of \$67.0M in Kindergarten to Grade 12 school funding for the 2025/2026 school year, with an increase of \$59.2M to public schools and \$7.8M to independent schools. Public school funding includes an increase of \$53.1M or 3.4 per cent in operating funding and a \$6M increase in capital support (primarily to address an increase in principal and interest payments). The \$30M for the universal nutrition program, announced in 2024/2025, has been continued with an additional \$6.7M in federal funding. The \$3M for smaller class sizes has also been continued from 2024/2025. For 2025/2026, there will also be an additional five community schools to ensure that students from high needs areas have the support they need.

Starting in the 2025/2026 school year, funding will be based on the best of the most current three years of actual eligible enrolment. This change provides predictability and responsiveness to growing school divisions, and protection to school divisions experiencing declining enrolment. To continue to make incremental improvements to the funding formula, the department will be reconstituting the Stakeholder Advisory Committee on School Funding to identify further opportunities to improve the way Kindergarten to Grade 12 public education is funded in our province.

This year's announcement builds on last year's progress, which enabled school divisions to lower Early Years class sizes, increase support to students, and add additional staff positions. The department is committed to predictable and stable funding increases to ensure that the sector has the funding necessary to support all students.

# **Community School Gathering March 2025**

The Community and School Relationships Unit of Indigenous Excellence is hosting a Community Connector Gathering on March 20, 2025, at 1577 Dublin Ave.

The Community Connector Gathering will provide an opportunity for Community Connectors from the 48 participating community schools to come together for a day of learning, networking, and relationship building.

Using the community school philosophy and model, Community Connectors work in conjunction with the school to support students and families utilizing the school as a community-level hub. Community Connectors identify, facilitate, and coordinate services, programs, and activities to support students, families, and the community.

The Community Connector Gathering will be led by community schools coordinator Melissa Brown and community schools mental health and wellness consultant Kim Shier.

# The Universally Accessible School Nutrition Program

The Universally Accessible School Nutrition Program was announced in January 2024 and formally launched this past September in time for the 2024/2025 school year. The program aims to ensure that, regardless of perceived needs, students in publicly funded schools in Manitoba have access to nutritious food at no cost, so they can focus on learning and reach their full potential.

In January 2025, Indigenous Excellence organized online meetings with school division superintendents, in collaboration with the Manitoba Association of School Superintendents. To ensure that all invitees could attend, the meetings were virtual, and discussions were facilitated by Indigenous Excellence staff.

The sessions provided the opportunity for a joint review of the 2024/2025 universally accessible school nutrition program design and rollout, allowing school divisions to share their experiences, provide feedback on the program, and help the department plan for program implementation in the 2025/2026 school year.


# Implementation Support for the Manitoba School Leadership Framework Has Begun

# Capital Investment in New Kindergarten to Grade 8 Schools and **Child Care Spaces**

The department is excited to announce the building of three new Kindergarten to Grade 8 schools: one in southwest Winnipeg, one in northeast Winnipeg, and one in West St. Paul. The locations were selected based on growth in student populations. Each school will be designed with future expansion in mind to account for continued enrolment growth, while also including infant and pre-school child care spaces.

Construction is anticipated to begin in 2026, with targeted opening dates in time for the start of the 2027/2028 school year.

# **Updated Educational Assistants in Manitoba Schools Publication Now Available**

#### Accessible Information and Communication Standard

The Accessible Information and Communication Standard Regulation, under The Accessibility for Manitobans Act, builds on existing requirements of Manitoba's Human Rights Code and requires organizations to identify, remove, and prevent barriers that exist digitally, in print, or through interaction with technology or people. It also adopts globally recognized web content accessibility guidelines as a minimum requirement.

All licensed early learning and child care centres, including nursery schools, as well as family and group child care home providers with one or more employees (including casual staff), are required to comply before May 1, 2025.


#### Prevention of Infection Within Child Care Facilities and Schools

Infection prevention and control measures are important to prevent the spread of infection in child care facilities and schools. The Routine Practices: Guide to Creating a Healthy Environment and Preventing Infections within Child Care Facilities and Schools document was developed to outline fundamental infection prevention and control measures in these environments. This document has many helpful tools, some of which are highlighted below.

Understanding what causes infection and disease is the first step to prevent and control its spread. For an infection to occur, a series of events need to take place, often referred to as the "chain of infection." Breaking any one of the six links in the chain will prevent infection from occurring.

Examples of breaks in the chain of infection:

- Stay home when sick, such as if you have a respiratory (coughing, sneezing) or gastrointestinal (vomiting, diarrhea) infection. This prevents germs from getting around (see "Germs Get Around" in the chain below). This is highlighted in the poster "You Can Help Prevent the Spread of Respiratory Illness."
- Practising cough etiquette helps break the chain of infection in how germs get out, germs get around, and how germs get in. See "How Germs Get Out" "Germs Get Around," and "How Germs Get In" in the chain below. This is highlighted in the poster "What Do You Do When You Go Achoo?".

# **Be Aware! Increased Malicious Emails and Phishing Attempts**

The department is aware of recent phishing attempts made to some of our sector stakeholders and partners.

Phishing attempts often involve a generic mass message, but it appears to be legitimate and typically contains a link or an attachment to download. The recent cases are emails that are represented as coming from various program areas in Manitoba Education and Early Childhood Learning.

This is a reminder to continue to be wary of phishing scams. Make it a practice to check email addresses in order to verify the sender's email address before clicking on any links or downloading attachments. Legitimate correspondence from the department will end with the domains @gov.mb.ca or @manitoba.ca. If an email address does not have one of these domains, the communication is not from us. Also look for red flags like urgent requests and spelling errors.

If a communication does not have a government domain, it is not from the department. Do not click on the link, do not download the attachment, report it as suspicious to your IT area if applicable, and delete.
